The following promotion is intended for participants in the United States, Canada (excluding Quebec), and the United Kingdom only and shall be construed and evaluated according to their applicable laws. - 1. DESCRIPTION: The "Doctor Who Watch to Win Sweepstakes" (the "Sweepstakes") is comprised of seven (7) "Entry Periods" as described in Section 3 below.  - Follow the on-screen prompts to share your Twitch ID with the Sweepstakes Entities and opt-in to participate in the Sweepstakes;
 - Watch at least ten (10) minutes of the Twitch Doctor Who Marathon within one (1) calendar day to receive one (1) virtual "**Ticket**" or "**Entry**" into the Sweepstakes.

Potential Weekly Prize Winners will be notified via the Twitch profile used to submit his or her entry within approximately ten (10) business days of the end of each Entry Period. Each potential Weekly Prize Winner will be required to respond (as directed by the Administrator and/or Sponsor) to the notification within forty-eight (48) hours (or a shorter time if required by exigencies) of first attempted notification. Potential Grand Prize Winner will be required to verify address and complete and electronically submit within seventy-two (72) hours (or a shorter time if required by exigencies) a declaration of eligibility, including a liability release, and, unless prohibited by law, a publicity release (the "Prize Claim Documents") covering eligibility, liability, advertising, publicity and media appearance issues. As a condition of receiving a prize, legal residents of Canada must first correctly answer without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill testing question.
